

### RIVER TRAILS SCHOOL DISTRICT 26 Chromebook Protection Plan

Dear Parent/Guardian,

River Trails School District 26 is providing and administering a protection plan for students and parents as part of our 1:1 Chromebook program. Enrollment in the District administered program is required if the chromebook is to go home with the student. To participate in the RTSD 26 Chromebook Protection Plan, Please complete the form.

The District plan covers "accidental damage" to the device and is designed to limit a family's financial responsibilities for any damages as described in the protection plan section below.

### Program Fee/Coverage

- Annual Non-refundable Cost: \$25
- Limit Liability: \$400
- Coverage: Repair/Replacement of school issued Chromebook and case

### **Effective Coverage/Expiration Dates**

- Effective Date: Based on the receipt of payment.
- Expiration Date: June 30, 2022.

### Coverage

- <u>Accidental Damage</u>: Pays for accidental damage caused by liquid spills, drops, or any other unintentional event.
- <u>Theft:</u> Pays for loss due to theft; the claim requires a police report to be filed.
- <u>Fire:</u> Pays for damage of the iPad due to fire; the claim must be accompanied by an official Fire report from the investigating authority.
- <u>Electrical Surge</u>: Pays for damage to the device due to an electrical surge.
- Natural Disasters: Pays for loss or damage caused by natural disasters.

\*Chromebook must be kept in district provided case\*

#### **Exclusions**

- <u>Dishonest, Fraudulent, Intentional, Negligent</u>
   (not locked/stored in an secure manner, or location) or <u>Criminal Acts</u>: Will not pay if damage or loss occurs in conjunction with a dishonest, fraudulent, intentional, negligent or criminal act. The student/parents will be responsible for the full amount of the repair/replacement.
- Consumables: AC adapter, and software.
- Cosmetic damage that does not affect the functionality of the device. This includes but is not limited to scratches, dents, and broken plastic ports or port covers.
- "Jailbreaking" or otherwise voiding the manufacturer's warranty by altering the software.
- RTSD 26 is not liable for any loss, damage (including incidental, consequential or punitive damages) for expenses caused directly or indirectly by the equipment.

<sup>\*\*</sup> If a student is unenrolled from RTSD 26 for any reason, the protection plan becomes null and void on that date and the Chromebook must be returned. There are no refunds once this agreement becomes active.

# RTSD 26 Chromebook Loan Agreement Chromebook 1:1 Initiative

Every student and parent/guardian participating in RTSD 26 Chromebook Initiative must adhere to the RTSD 26 Program Policies, Student Code of Conduct, Student Handbook, Acceptable Use Policy, Board policies, and federal/state laws.

### **Device Specifics:**

For RTSD 26 1:1 Chromebook initiative purposes, the technology device covered by this agreement is a Chromebook. One Chromebook, 12W USB power adapter, and case are being loaned to the student. It is the student's responsibility to care for the equipment on a daily basis and ensure that it is retained in a safe environment. The student will need to purchase or provide his own earbuds. Any technical or mechanical issues with the Chromebook must be reported to the school for evaluation and repair.

This equipment is, and at all-time remains, the property of RTSD 26 and is subject to inspection. The equipment may be collected during the final week of school, or sooner if a student leaves, withdraws, is expelled, or goes to an alternative school from District schools prior to the end of the school year.

### Student Responsibilities:

Your Chromebook is an important learning tool and is for educational purposes. In order to take the Chromebook home each day, each student must be willing to accept the following responsibilities:

- My Chromebook is my responsibility and I will not leave it in unsupervised areas.
- I will honor RTSD 26 Acceptable Use/Internet Safety Policy and the Chromebook Handbook guidelines when using the Chromebook at home, and will not view, send, create, or download inappropriate material.
- I will bring the Chromebook to school every day with a fully charged battery.
- I will treat the Chromebook appropriately and will report any mechanical or technical issues immediately to the school.
- I will use my best efforts to ensure that the RTSD 26-owned Chromebook is not damaged, lost, or stolen while in my possession.
- I will not remove the school-issued Chromebook case from the Chromebook.
- I will not remove or modify the identification and inventory labels that have been placed on the Chromebook. I will not add stickers, labels, tags, or markings to the Chromebook.
- I agree to use the Chromebook only for appropriate, legitimate, and responsible communications. I will not access unauthorized social media sites.
- I will keep my accounts and passwords secure and will not share these with any other students, siblings, or friends.
- I will not attempt to add, delete, access, or modify other user accounts on the Chromebook.
- I will take no action that could interfere with the RTSD 26 network.
- I will return the Chromebook in good working order when requested, or upon leaving, expulsion, suspension, assignment to an alternate school or withdrawal from River Trails 26.

### Parent/Guardian Responsibilities:

Your son/daughter has been issued a Chromebook as a part of the RTSD 26 Chromebook 1:1 Initiative to improve and personalize his/her education this year. It is essential that the following guidelines be followed to ensure the safe, efficient, and ethical operation of this device:

- I will supervise my son's/daughter's use of the Chromebook at home.
- I will discuss the Acceptable Use/Internet Safety Policy and Chromebook Handbook guidelines with my child.
- I will relay the expectations of RTSD 26 regarding the use of the Internet and email at home and will supervise my child's use of the Internet and email.
- I will ensure that my son/daughter reports any mechanical or technical issues to the school.
- I will ensure that my son/daughter understands the Student Responsibilities outlined in this Loan Agreement.
- I will periodically check my child's Chromebook for inappropriate content and/or applications.
- I agree that the Chromebook will be returned to District when requested or upon my son's/daughter's leaving, expulsion, suspension, assignment to an alternate school, or withdrawal from District 26.
- I will reimburse the District for what is deemed intentional damage to any of the equipment.
